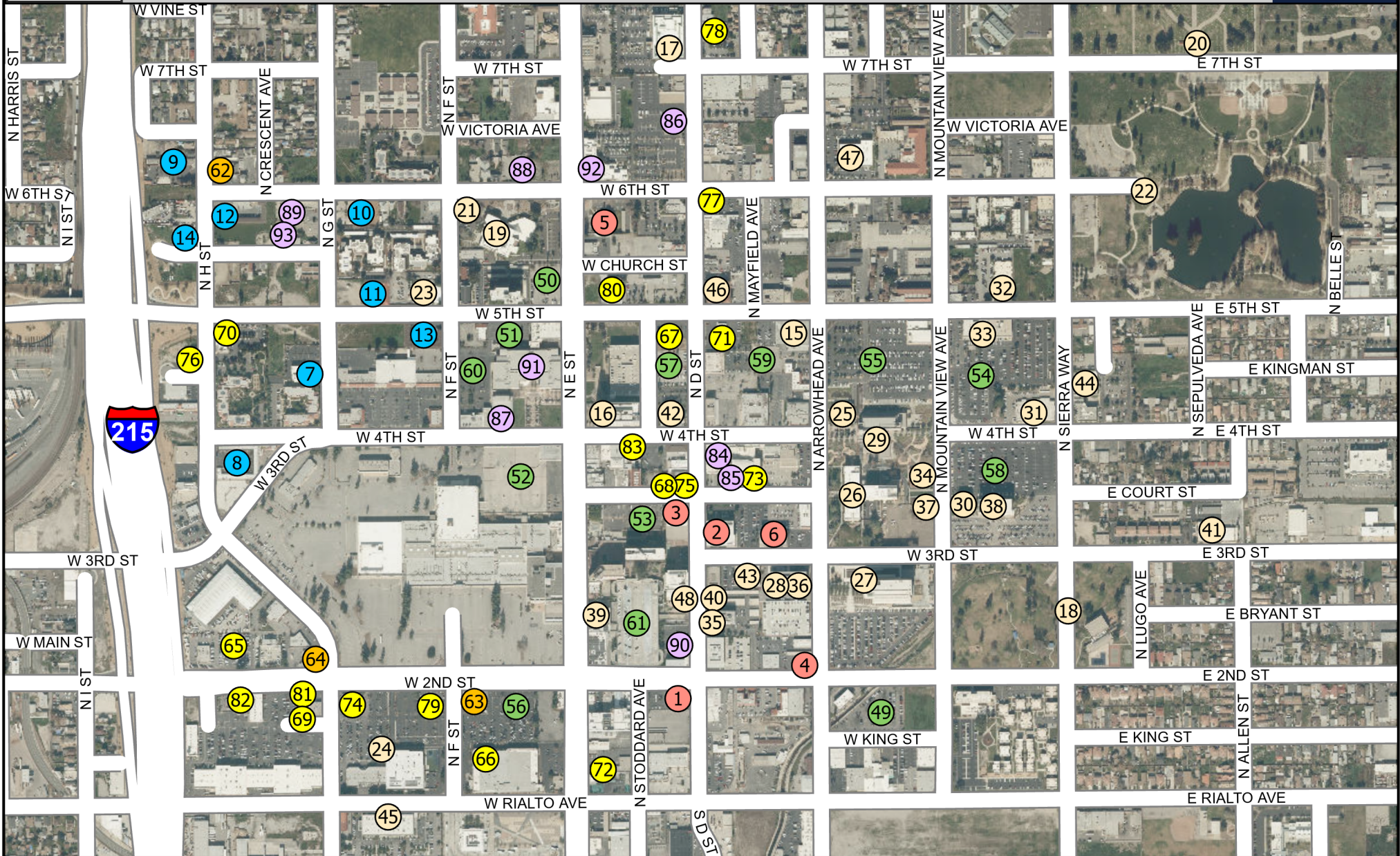


City of San Bernardino - Downtown Area Map
